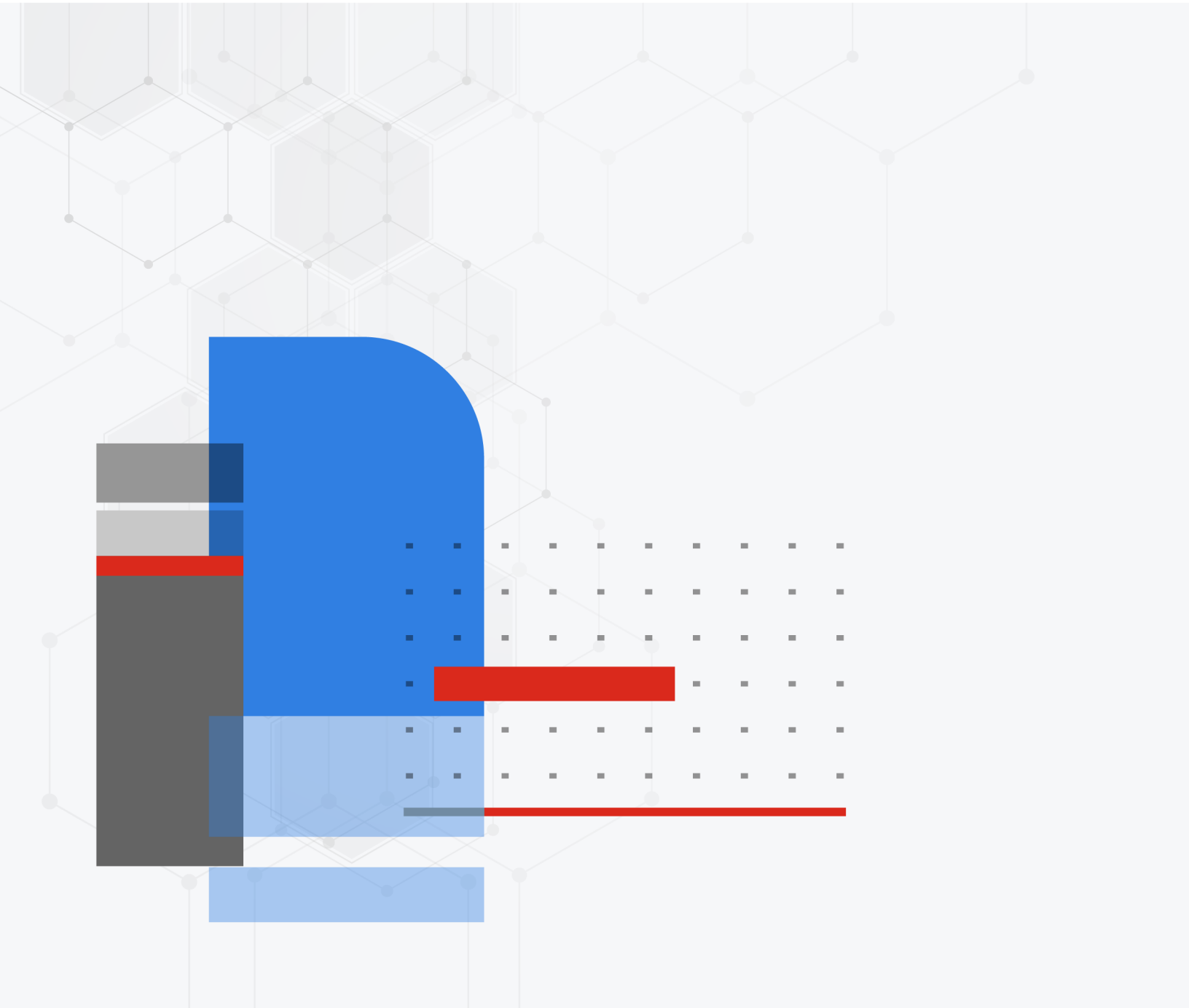

FortiEdge Cloud Licensing

This release delivers the transition of FortiLAN Cloud into FortiEdge Cloud, that is a unified management platform for standalone FortiAP, FortiSwitch, and FortiExtender deployments. FortiEdge Cloud introduces a new licensing regimen that extends to the devices that it manages.

FortiLAN Cloud vs FortiEdge Cloud

This section gives you a gist of the changes introduced in this release of FortiEdge Cloud compared to the licensing terms in the FortiLAN Cloud releases.

No Support for FortiCloud Premium

After you upgrade to the current FortiEdge Cloud, the FortiCloud Premium license status will freeze

- Any new FortiCloud Premium license purchases and renewals made until the **day of the upgrade** will be applied and will function until their expiry.
- New FortiCloud Premium licenses purchased/renewed after upgrade will **NOT** be applied.
- The license status will be appropriately updated in the **Devices** and **Manage Account Access** pages of the GUI.

Reduced Freemium Device Counts

The existing Freemium device counts will be reduced as per the following details starting **March 31, 2025**.

Devices	FortiLAN Cloud	FortiEdge Cloud
FortiAPs	30	15
FortiSwitches	3	1

Notes:

- [Existing Accounts] A grace period is given if your network exceeds the existing device count; the grace period is valid until March 2025.
- Freemium is **NOT** applicable to FortiExtender devices.
- Freemium wireless feature support is revised, see [Service Offerings](#).

Subscription Offering

FortiEdge Cloud offers the following licensing options for product subscriptions. For more information about acquiring licenses, contact the *Fortinet Customer Support* team.

Subscription	Description
Freemium	Free subscription for FortiEdge Cloud.
Device License	A license is bound to each device (FortiAP/FortiSwitch/FortiExtender).
Account License	A license is bound to the FortiEdge Cloud account.

The following are the details on the Freemium subscription that imposes a device count limit and offers a grace period.

- A FortiEdge Cloud **Freemium Account** license allows deploying a maximum of 15 un-licensed FortiAPs and 1 FortiSwitch across networks with basic management functions.
- You cannot deploy any more un-licensed devices or create/modify networks, and any additional devices (deployed beyond the permissible limit) are un-deployed.
- Click on the  (warning) icon in the GUI, to view the grace period details and the network/devices. An additional 60 days grace period is given to any device with a valid license that is expiring.
- After the grace period, the system randomly retains (up to) a maximum of 15 Freemium FortiAPs and 1 Freemium FortiSwitch. Any other FortiAPs/FortiSwitches are not allowed to connect to the service, but can retain their configuration.

Notes:

- FortiAP-U models require an additional license for the Universal Threat Protection (UTP) feature. You are required to purchase this license in addition to the advanced management license.
- For advanced management, you must purchase a license for each FortiAP and FortiSwitch device.
- Each licensed FortiExtender device gets a 2 month grace period after the license expiry. For more information, see [License Information](#).
